Your pet is important to us. Because we care, we want to assure you that every effort will be taken to make your pets visit as pleasant and enjoyable as possible. Due to the unpredictable behavior of animals, situations arise that are unexpected. Please initial any of the following pertaining to your pet.

____ Medical Condition: Occasionally, grooming can expose a hidden medical problem or aggravate a current one. This can occur during or after grooming.

____ Senior Pet: I understand that senior pets (age 7 or higher) may have a greater chance of injury.

____ Matted Pet: Because my pet is severely tangled and/or matted, it is a greater risk of injury, stress and trauma. All precautions will be taken. However, problems occasionally arise, during or after grooming, such as nicks, clipper irritation, and mental or physical stress.

____ Photo Release: Fancy Paws of Wellsboro reserves the right to take, share and post any or all photos taken of our clients, as this is how we best market our services.

You are not allowed to stay and watch your pet or hold for grooming. This is dangerous to all parties involved. You will be contacted by your groomer at least 15 mins before the groom is done. Pick up will need to be no later than 30 mins after groom is complete, to allow room for the next client coming in. An additional fee will be charged for dogs not picked up in time.

No Show Policy

At Fancy Paws of Wellsboro we do understand that there are unforeseen things that happen. If you are unable to keep your appointment time give us a 48 hour notice by giving us a call, so that we can try to fill your time slot.

1st No Show: \$15 per pet

2nd No Show: 50% of groom per pet

3rd No Show: All future appts must be prepaid per pet & we reserve the right to dismiss you as a client.

If you are more than 15 minutes late without letting us know/without being okayed by your groomer, you will be considered a no-show/no call and the no-show policy will apply.

As an owner/operator of a small business we rely on our customers to show up to their appointments. If clients don't show up and we are unable to fill the spot last minute we lose income. So please be respectful and let us know if there're any issues with keeping your appointment.

- I understand that due to the nature of pet grooming all quoted prices prior to actually grooming my pet are only estimates. Final price will depend on the temperament of each pet and the condition of its coat. Upon physical inspection of my pet by the groomer a good faith estimated price will be provided. Extra charges may apply for pets that are matted and/or difficult to manage.
- I understand Fancy Paws of Wellsboro has the right to refuse service to me and my pet at any time for any reason.
- I understand Fancy Paws of Wellsboro will charge me a \$50 handling fee for returned checks.

Liability

- I (_____) understand that if my pet has a history of aggression or biting, Fancy Paws of Wellsboro LLC reserves the right to refuse service and all bites will be reported to the local authorities as required by law.
- I understand that I am liable for any medical care expenses and damages that result from injuries caused by my pet.
- I expressly waive and relinquish any and all claims against Fancy Paws of Wellsboro LLC, its employees and representatives, except for those arising from negligence on the part of Fancy Paws of Wellsboro LLC.
- I have disclosed to Fancy Paws of Wellsboro all known dangers associated with my pet.
- I expressly understand and agree that Fancy Paws of Wellsboro LLC shall not be held responsible for any damage to my property.
- I understand that under no circumstances will Fancy Paws of Wellsboro LLC be liable for consequential damages or damages.
- If any medical problems develop while my pet is in the care of Fancy Paws of Wellsboro, I authorize Fancy Paws of Wellsboro LLC to do whatever is necessary for the safety, health and wellbeing of my pet. Further I assume full financial responsibility for any and all expenses incurred.
